The Kick Start scholarship is for small businesses, start-ups and individuals with 5 or less employees (including owner), in the City of Redding, meeting certain income levels.

Please fill out the following application and income eligibility form. You will need to provide proof of your income such as pay stub.

Shasta EDC receives a grant through the City of Redding to provide this scholarship and is required to collect this data. All information will remain confidential.

Please refer to the income guidelines below to help you determine eligibility. Your income can be up to 80% of the median income of the area. For example, if your family size is 1 (yourself) and your income is at or below \$39,800 annually or \$3,317 monthly, you would qualify.

## Income Verification Documentation

Along with the CDBG Income Eligibility Certification form, we will need you to submit proof of each income item listed in the "Income Verification Data" section of the form. Acceptable proof of income includes:

Paycheck Stub

P&L Statement

Pensions and annuities – latest check stub from issuing institution

Social security - current award letter

Unemployment compensation - claim payment history of most current month

SSI - award letter

TANF - award letter, recent check stub

Worker's compensation - Form DOL 203, recent check stub

Alimony -- copy of court order Child support - copy of court order Education scholarships/stipends - award letter

Trade union benefits - recent check stub

Other public assistance - award letter

Income from assets -credit union/bank/S&L statements, etc.
